WHO WILL STAFF THE VENDOR BOOTHS & KEEP AN EYE ON ITEMS?

The Dairy Barn staff & select volunteers will be on hand to assist shoppers and ring up their purchases and to monitor for loss/theft. We will have one central checkout. You as the vendor will leave your booth up for the 10 days of shopping and leave the rest to us. We also have a security system that will be set each night at closing.

WILL VENDORS NEED TO PROVIDE THEIR OWN DISPLAYS?

Yes! Vendors will have to provide their own tables, chairs, display materials. If you would like electricity please indicate it on the registration form.

CAN VENDORS VOLUNTEER TO WORK AT THE 2020 HOLIDAY BAZAAR?

Yes absolutely! We will need volunteers and will be reaching out to vendors for their availability.

HOW WILL I BE PAID FOR SALES OF MY ITEMS?

Vendors will receive 100% of their item sales and are responsible for reporting any tax and obtaining any necessary vendor's licenses. You will receive a check from The Dairy Barn at the end of the event for your item sales.
